Regular Monthly Board Meeting Minutes Wednesday: February 08, 2023

- 1. Chairman, David Jelinek called to order the regular monthly board meeting at 6:00 p.m. Board Officials Present: Chairman- David Jelinek, Supervisors- Aaron Palmer and Matt Schmitz, Treasurer- Jane Ewing, Clerk- Linda Wymer.
 - A. The board meeting was opened with the Pledge of Allegiance.
 - B. The meeting was posted at the Town Garage and posted to the Town's website.
 - C. Matt Schmitz made a motion to approve the agenda, it was seconded by Aaron Palmer. The motion carried.

- 2. The WTA District meetings agendas were reviewed, no registrations at this time.
- 3. David Jelinek reported on attending the RRFD meeting in January. Lacy Luxton accepted the new fire board secretary position. The Fire Board Annual report was given.
- 4.Town Road Discussions: There was a discussion around mailboxes being hit during plowing during the last snowfall on Crestview Drive, most have been replaced. There was also a discussion about the snow plowing on Maple Ridge Road.
- 5. Linda Wymer presented 16 items to be paid in the amount of \$ 44,843.94. The Town Treasuer, Jane Ewing, had not received Februarys Tax Settlement from the Richland County Treasurer yet. Matt Schmitz made a motion to pay the Towns Bills, Aaron Palmer seconded the motion. The motion carried.
- 6. Treasurer, Jane Ewing, gave the treasurers report. Last month's debits totaled \$805,326.74 and deposits to the checking account were \$754,365.87. The town's checking account balance at Peoples Community Bank is \$77,531.03. The Towns reserve account balances are: Tax Account \$674,016.02, Escrow Account \$85,675.17 and the ARPA Fund Account \$51,672.88. Matt Schmitz made a motion to transfer the February Settlement from the Tax Savings Account to the Checking account to pay the February Settlement when the settlement figures arrive from the Richland County Treasurer; Aaron Palmer seconded the motion. The motion carried. Aaron Palmer made a motion to approve the Treasurer's Report as given; it was seconded by Matt Schmitz. The motion carried.
